- 4. Attendance at Annual General Meeting
- 5. Be informed of the services provided by PRTRA and publicly support them.
- 6. Prepare for and participate in the discussions and the deliberations of the Board.
- 7. Foster a positive working relationship with other Board Members and PRTRA Staff.
- 8. Be aware and abstain from any conflict of interest.
- 9. Satisfactory Criminal Records Check
- 10. Must be a minimum of 18 years of age.
